39th Annual Meeting - March 4-6, 2010

THE CONFERENCE

The 39th annual meeting of the Society for Pentecostal Studies convenes March 4-6, 2010, at North Central University, under the theme “New Voices, New Visions: Future and Hope of Pentecostal Theology.”

Pentecostals readily affirm their openness to the leading of the Spirit in their personal journey as well as in their communities of worship; but the question remains: what is the Spirit saying and where is the Spirit leading with regard to the theology of the movement? Is it possible to maintain a Pentecostal theological identity but express that identity in new ways? Are there lessons we should learn from our past as we enter the next era? How is theology being shaped by Pentecostal voices from the majority world? Are there new methods to be engaged for the formation of Pentecostal leaders? What theological visions are being given to our sons and daughters? Are there voices from outside the tradition that may serve to inform us and to shape our future? The 2010 meeting of the Society for Pentecostal Studies will explore this future and raise these questions through a program of both plenary and parallel sessions from the perspective of various of academic disciplines.

The plenary sessions of the program have been constructed to reflect the diversity of voices and disciplines by which Pentecostal theology is being and likely will be formed. **Rickie D. Moore** (Lee University) is a noted Old Testament scholar. He is the author of *God Saves: Lessons from the Elisha Stories* (Sheffield Academic Press, 1990) and was a founding editor of the *Journal of Pentecostal Theology*. The opening session of the 2010 meeting will include a sermon by Moore, “**New Voices, New Visions: The Promise of the Father to a (Grand)Parent’s Cry.**”

Terry LeBlanc is Mi’kmaq/Acadian, from Listuguj First Nation and Campbellton, NB, Canada. He is Director of the North American Institute for Indigenous Theological Studies (NAIITS) and Executive Director of “My People International.” He is managing editor of the NAIITS journal and contributor to various scholarly publications including the Edinburgh 2010 documents. He serves as adjunct at Asbury Theological Seminary where he is completing his Ph.D. in Intercultural Studies. LeBlanc’s address is titled “**Spirit and Spirituality: New Old Perspectives.**”

Margaret M. Poloma (Professor Emeritus, University of Akron) and **Matthew T. Lee** (University of Akron) are co-directors (with Stephen G. Post and John C. Green) of the Flame of Love Project, an interdisciplinary research project exploring Godly Love in the Pentecostal tradition. Poloma is author of numerous books including *The Assemblies of God at the Crossroads: Charisma and Institutional Dilemmas* (University of Tennessee Press, 1989) and *Main Street Mystics: The Toronto Blessing and Reviving Pentecostalism* (AltaMira Press, 2003). Her research collaborations in the Flame of Love Project have resulted in several publications. With Ralph W. Hood Jr., she co-authored *Blood and Fire: Godly Love In A Pentecostal Emerging Church* (NYU Press, 2008); and with Lee, *Social Filters of Godly Love: A Sociological Study of the Great Commandment in the Pentecostal Context* (Edward Mellen Press, 2009). Poloma and Lee will explore the integration of social science and Pentecostal theology in a plenary session titled “**Harvesting New Fields of Study: Lessons from Research on Godly Love.**”

Tony Jones will address the subject **“Emerging Spiritualities: What Pentecostalism and the Emerging Church Movement Have to Learn from One Another.”** He is a doctoral fellow in Practical Theology at Princeton Theological Seminary and theologian-in-residence at Solomon’s Porch in Minneapolis. He is author of numerous books including *The Sacred Way: Spiritual Practices for Everyday Life* (Zondervan/Youth Specialties, 2005), *An Emergent Manifesto of Hope* (Baker, 2007), *Postmodern Youth Ministry: Exploring Cultural Shifts, Creating Holistic Connections, Cultivating Authentic Community* (Zondervan/Youth Specialties, 2001), and most recently *The New Christians: Dispatches from the Emergent Frontier* (Jossey-Bass, 2008).

Offering a response to Jones will be **Cheryl Bridges Johns** (Pentecostal Theological Seminary). Johns is the author of *Pentecostal Formation: A Pedagogy Among the Oppressed* (Sheffield Academic Press, 1993) and numerous other publications in the area of Christian formation and the life and work of the Pentecostal church. A past president of the society, Johns is a frequent speaker at ecumenical conferences around the world. Most recently she has been at the forefront of the Evangelical and Pentecostal discussions regarding the care of Creation.

Veli-Matti Kärkkäinen (Fuller Theological Seminary) is the author of numerous books and articles. Among his publications are *The Trinity: Global Perspectives* (Westminster John Knox Press, 2007), *One With God: Salvation as Deification and Justification* (Liturgical Press, 2004), and *Trinity and Religious Pluralism: The Doctrine of the Trinity in Christian Theology of Religions* (Ashgate, 2004). Most recently Kärkkäinen has edited a volume called *The Spirit in the World: Emerging Pentecostal Theologies in Global Contexts* (Eerdmans, 2009). The closing banquet of the 2010 meeting will feature a conversation with Kärkkäinen about these emerging theologies. **Frank Macchia** (Vanguard University), contributor to the volume and author of *Baptized in the Spirit: A Global Pentecostal Theology* (Zondervan, 2006), will facilitate this conversation.

Estrela Alexander (Regent University) is author of *The Women of Azusa Street* (Pilgrim Press, 2007) and *Limited Liberty: The Life and Legacy of Four Pentecostal Women Pioneers* (Pilgrim Press, 2008). She will deliver the Presidential Address titled **“When Liberation Becomes Survival.”**

REGISTRATION

Registration for the conference will be held at the Minneapolis Radisson Plaza Hotel in the Scandinavian Ballroom Lobby beginning Wednesday afternoon. On Friday, registration will move to North Central University. Please note the registration times provided in this program at the beginning of each day's events. **Only those persons wearing conference name badges will be admitted to sessions (except for the Opening Plenary which is open to the public).**

ACCOMMODATIONS

The 2010 host hotel is the **Minneapolis Radisson Plaza Hotel**, the flagship hotel of the Radisson chain, which is headquartered in a Minneapolis suburb. The Radisson Plaza is located at 35 South Seventh Street, Minneapolis, MN 55402. Reservations can be made at (612) 339-4900 or via fax at (612) 337-9766. Online reservation is available at www.sps-usa.org/meetings/home.html on the SPS Annual Meeting information page.

Reservations should be made by **Tuesday, February 9**, to insure the conference rate of **\$120 per night (plus applicable taxes)** for up to two guests. Rollaways for up to two additional guests per room may be added for \$15 per night per rollaway. Be sure to mention that you are with the Society for Pentecostal Studies in order to receive the conference rate. The number of rooms are limited so we encourage attendees to make a reservation as early as possible, especially those arriving on Wednesday. The Radisson Plaza will provide SPS attendees staying at the hotel with free internet connectivity.

Thursday's day sessions, Friday's evening session, the Saturday lunch discussion on Pentecostalism and the Emergent Church, and the Saturday banquet will be at the Minneapolis Radisson Plaza Hotel.

All other sessions will be held on the North Central University campus, located at 910 Elliot Avenue, Minneapolis, MN 55404. The number of the college is (612) 343-4400 and Anh Weinacht is the contact person. The university is less than a mile from the Minneapolis Radisson Plaza Hotel.

TRANSPORTATION AND PARKING

The **Minneapolis-St. Paul International Airport (MSP)** is a major airport with flight service provided by most major American airlines and many international airlines. In addition, it is a Delta/Northwest hub. The MSP airport has two terminals: the (main) Lindberg Terminal and the Humphrey Terminal. (The Airport has announced plans to rename these terminals: Lindberg to Terminal #1 and Humphrey to Terminal #2. It is unclear how the signage will read in March.) Air Tran, Champion, Iceland Air, Midwest, Sun Country, and several charter services fly out of the Humphrey Terminal. The other airlines use the Lindberg Terminal. A free tram connects the terminals.

Taxi service, shuttles, and bus service are available from the MSP airport. The cheapest and simplest way to get to downtown Minneapolis where the SPS annual meeting is being held is via Light Rail Transit (LRT). For information about using the LRT, see "Using Light Rail Transit" listed below.

An alternative is the **Super Shuttle**, which costs about \$16 plus tip each way for a shared ride. The phone number for the Minneapolis-St. Paul office of Super Shuttle is (612) 827-7777.

Those staying at the Minneapolis Radisson Plaza Hotel may park cars there for an additional fee (\$18 per weekday and \$5 per day on the weekend, with in-and-out privileges). North Central University will provide free parking on its campus from 3 p.m. Thursday, March 4, through 12:00 noon Sunday, March 7.

Using Light Rail Transit (LRT)

A convenient and inexpensive way to get to the Radisson Plaza from the Minneapolis–St. Paul International Airport (MSP) is via light rail transit (LRT). The trip takes about 25 minutes and for most people costs either \$1.75 or \$2.25, depending on the time of day. (For Seniors the fare is only \$.75 during non-rush hours, and for the disabled it is \$.75 at any time.) The Twin Cities Metro currently has only one functioning LRT. It is called the Hiawatha (Route 55) Line.

When travelling back and forth from the airport to the conference hotel, keep in mind the two LRT stations at the airport (one at each terminal) and the Nicollet Mall Station (which is about two-and-a-half blocks from the Radisson Plaza).

The Hiawatha Line LRT operates each day from 5:00 a.m. until 1:00 a.m. The trains come about every 7 or 8 minutes during rush hour (6:00-9:00 a.m. and 3:00-6:30 p.m.), about every 10 minutes during mid-day, and about every 15 minutes in the evening.

Buying Tickets

Tickets may be purchased from vending machines located at or near the LRT stations using bills (\$1, \$5, \$10, and \$20), coins, and credit cards (VISA, MasterCard, American Express, and Discover). LRT tickets do not specify the place of departure or the destination and allow riding the LRT anywhere for a period of two-and-a-half hours from the time of purchase.

At the Lindberg Terminal LRT Station the ticket vending machines are located up the escalators from the train platform. The ticket vending machines are located on the train platform at the Humphrey Terminal LRT Station and Nicollet Mall LRT Station.

Getting to the Airport LRT Station

It is necessary to take a free 30-second tram ride from the Lindberg Terminal to the Lindberg Terminal LRT Station. A five-minute walk is required to get from the Humphrey Terminal to the Humphrey Terminal LRT Station.

Getting to the Radisson Plaza Hotel from the Nicollet Mall LRT Station

From the Nicollet Mall LRT station (1) walk half a block west to Nicollet Avenue, (2) walk two blocks south on Nicollet to S. 7th Street, and then (3) walk half a block west to the Radisson Plaza Hotel, which will be on the left side of the street.

MEALS

Light refreshments will be served during the **reception** on Thursday night as well as during the morning and afternoon breaks on Friday and Saturday.

Bag lunches may be purchased no later than the prior afternoon for \$5.00 per day for Friday and/or Saturday. The bag lunch will consist of a sandwich, bag of chips, cookie, piece of fruit and beverage (choice of lemonade or bottled water). The sandwich choices are 1) turkey and Swiss cheese; 2) ham and American cheese; or 3) veggie and American Swiss (white colored American cheese). Those attending an Interest Group and other meetings are encouraged to purchase a bag lunch.

The **NCU cafeteria** will be open during the lunch hour on Friday and Saturday. For conference attendees, the cost of lunch will be \$4.85 including tax.

A lunch discussion on “**Pentecostalism and the Emergent Church**” with Cheryl Johns and Tony Jones will be at the Radisson Hotel on Saturday. The cost is \$24 (Caesar salad, chicken primavera, desert and beverage) and must be purchased no later than February 28.

Evening meals on Thursday and Friday are on your own and not available through the conference registration.

The **Saturday banquet** will offer three meal choices: Grilled Turkey Scaloppini (Sage & Prosciutto Cream Tagliatelle, Broccolini and Aged Asiago), Yankee Pot Roast (Roast Potatoes, Peas, Braised Carrots, Onion and Celery in Savory Beef Gravy) and Pappardelle (Asparagus, Summer Squash, Arugula, Cherry Tomatoes, Pine Nuts, Parsley Pesto and Shaved Parmesan). The cost for a banquet ticket is \$36.00. Pre-registration for the banquet will ensure your banquet meal choice. There is no guarantee that banquet tickets will be available for purchase at the conference.

The **Second Annual Women’s Caucus Breakfast** will be Friday from 7:00–8:15 a.m. in the Radisson’s Minnesota Room. The cost for the Hot Plate Breakfast is \$20.00. Current and emerging women scholars and students are invited to come together to network with each other, celebrate our accomplishments in the churches and academy, and strategize regarding our ongoing impact in these spheres. MINNEAPOLIS SPECIAL SIGHTS

Those attending the annual meeting might enjoy visiting Mall of America while in Minneapolis. A convenient way to do this is via the LRT. The conference hotel is near one end of the Hiawatha Line; the Mall of America is at the other end. A one-way trip from the Nicollet Mail LRT station (the one nearest the conference hotel) to the Mall of America LRT station lasts about 35 minutes. From the Metrodome LRT Station (the station closest to North Central University, about five blocks away) the trip lasts about 30 minutes.
